Schedule a blood lead test for your child today

Did you know that lead poisoning can affect your child's ability to think clearly and concentrate in school? It can also cause behavioral problems.

Fortunately, a simple blood lead test can determine if your child's blood lead level is normal. This lead test is part of the Child and Teen Checkups (C&TC) screening your child needs at 12 and 24 months of age. And remember: C&TC visits and lead tests are a covered benefit for all eligible UCare members. No co-pay, or charge, is required.

Get a \$50 gift card.

You may be eligible for a \$50 gift card from UCare if you have your child tested. Have your health care provider complete and sign the attached voucher. Then mail the completed voucher to the address on the back to receive your gift card.
